Factor's For Increase In Auditor Time:

- Complicated logistics involving more than one building or location where work is carried out
- Staff speaking in more than one language (requiring interpreter(s) or preventing individual auditors from
- Very large site for number of employees (e.g., a timber land (forest))
- System covers highly complex processes or relatively high number of unique activities
- High risks products/activities/processes
- High degree of regulation (food and drugs, aerospace, nuclear power, etc.)
- Other standards to take in account: complementary certification ("ISO 9001+")
- Other particular standards to take in account during the audit
- Processes involve a combination of hardware, software, process, and service

Factor's For Decrease In Auditor Time:

- Organization is not "Design Responsible" and/or other Standard elements not covered in scope
- Simple processes, no/low risk product/processes
- Very small site for number of employees (e.g., office complex only)
- Processes involve a single general activity (e.g. Service only)
- High percentage of employees doing the same, simple tasks
- Employees working in shift system
- Prior knowledge of organization system (e.g. already certified to another Standard by the same certification body)
- Client preparedness for certification (e.g. already certified or recognized by another 3rd party scheme)
- Well developed and implemented system
- Maturity of the management system: 2 or 3 renewal
- Combined with other Management Systems
- Combined certification
